- v. List of clients for which similar work was performed
- vi. Technical Specifications and information of quoted product.
- vii. Commitment to complete the work in stipulated time mentioned in the Bidding Document.

- 1. Subject procurement is being made as per provisions of Sindh Public Procurement Rules, 2010.
- 2. All bids/ tenders in sealed envelopes accompanied with Bid Security at 2% of Bid Price in the form of Bank Draft/ Pay Order in favour of Managing Director, Thar Coal and Energy Board, must be submitted with each offer. Single stage two Envelope methods as mentioned in Sindh Public Procurement Rules, 2010 will be used. The Technical and Financial Proposals should be marked on the envelopes.

The Bidding Document containing detailed terms and conditions, specification of supply & installation of above mentioned item and evaluation criteria can be obtained on written request on the letterhead of company/ firm, from the office of undersigned (without any fee) on any working day during office hours on or before 11.00 am, 30th April, 2014.
